## Dear Council Members,

As we enter the sixth week of session, we've learned how the Senate and House want to divvy up the state budget, that Internet cafes have almost no friends in the Legislature, and that at least one Senate committee was willing to endorse a domestic partnership bill.

Both chambers of the Legislature advanced their own budget plans last Wednesday, with Senators tacking on amendments giving money to favored projects, including \$123 million for state college construction and maintenance projects. While the Senate Appropriations Committee received unanimous support for its \$74.3 billion spending plan, Democrats on the House Appropriations Committee voted against the \$74.4 budget, mainly over frustration with Republican House leaders for their refusal to expand Medicaid as envisioned by the federal Affordable Care Act.

New legislation would have Florida match most other states in how it handles scientific evidence in the courtroom. HB 7015 was passed by the Judiciary Committee on Wednesday (April 3<sup>rd</sup>) and placed on the House calendar. Legislators tried to pass a bill adopting the *Daubert* standard in 2012, though it died in the House on the last day of session. This year there are two bills, HB 7015 sponsored by Rep. Larry Metz, R-Yalaha, and SB 1412 sponsored by Sen. Garrett Richter, R-Naples. SB 1412 was referred to the Judiciary and Rules committees on March 6.

On Thursday (April 4<sup>th</sup>), the Senate approved SB 718, which next goes to the House. The bill would put an end to permanent alimony and make it more difficult for alimony to be granted in marriages shorter than 10 years. The chairwoman of The Florida Bar's Family Law Section said that although the legislation is "not billed as being sexist, but it will affect, definitely, more women than men." A similar bill in the House is pending on its calendar for probable debate this week.

### **HB 7131 - Relating to Ethics**
