Committee Reports

CLE Committee

Michael G. Tanner reported on the upcoming CLE schedule. All of the seminars have program chairs except the October 9/10 seminar. He thanked those who have agreed to participate as program chairs for the upcoming year.

Discovery Handbook Update Committee

Michael G. Tanner asked the council to assist in the revision of the Discovery Handbook. Each chapter has been assigned. Anyone interested in assisting the committee was asked to contact Mike. The revisions or additions should be completed by December.

Legislation Committee

Buddy. Jacobs introduce Rep. Tom Warner and Rep. Robert D. Trammell to the council and they in turn gave a summary of this past legislation session and possible issues in the upcoming session. Buddy then discussed specific issues that will need to be watched as the upcoming session approaches.

Bylaw Committee Rule Change

The Bylaw changes that were proposed at the April 13, 1996 meeting were approved by the council and will be presented to The Florida Bar Rules and Bylaw Committee. The changed language will read... For the purpose of this sections bylaws and this paragraph Florida Legal Assistant shall mean a person who is employed by and supervised by a member of The Florida Bar of law firm and who has satisfied the following minimum requirements:...

Proposed Amendment to Rule 4-1.5 (f)(4)

John M. Kest reported on the proposed amendment to Rule 4 - 1.5 (f)(4). After a discussion of the council they recommended section 4-1.5 (f)(4) be changed to allow a 30 percent contingency fee in cases with awards between \$2 million and \$3 million where liability is admitted, but the case goes to trial. The rule currently allows 20 percent. For cases yielding awards of more than \$3 million, the committee recommended that the fee be increased from 15 to 20 percent. John will pass the councils recommendation on The Florida Bar.
